7. Pendle Hill Partnership – Churn Clough Circular Route

8. Heritage Trail- Calico & Clogs

Clr M Pilkington reported both schools have committed, further discussions over the next few weeks. Mr T Lingard has agreed to judge the of logos.

Mid Pennine Arts are interested in supporting and keen for the restoration of the bust of Richard Cobden and the Sundial, which will both add interest to the trail.

Due to the pandemic Clr M Pilkington will be discussing with PHP the implications if there is a delay with the timescale. The sub committee will be holding a virtual meeting within the next few weeks.

9. Consideration was given to traffic/speeding issues

Following on from the initial concerns expressed last month LCC were contacted and responded as follows

In relation to your concerns about the speed of traffic, we work closely with the Police as part of the Lancashire Road Safety Partnership to target locations where casualties and speeds are higher. If there is an evidenced safety issue, we will look to introduce appropriate mitigation measures.

Having previously assessed Clitheroe Road, we installed temporary signage to help remind drivers to think about their speed between April and June 2020 and between October and December 2020 to maximise the effect of the message. Clitheroe Road will also be considered by Lancashire Constabulary as a site for mobile enforcement.

After investigation, there is no clear speeding issue on Padiham Road that would justify action from the Speed Management Team. However, there is a <u>community toolkit</u> on our website, which gives examples of how local residents can raise awareness of road safety issues in their local area

Councillors briefly discussed the main issues of Pedestrian Safety, Traffic Speed & volume and thought it may be beneficial to set up a Community Road Watch Group. The LCC response will be publicised and at the same time we will ask for volunteers. Clr Justin Smith will happily be involved.

10. Consideration was given to a project for planting a hedge along the brook banking near Watt St Bus Shelter via Woodland Trust Application

Clrs A Haworth & S Clarke met and came up with a proposal to plant a hedge along the Brook side for safety reasons- . Unfortunately due to the current restrictions in relation to the pandemic the Woodland Trust are not accepting any applications. However, Mr Steven Howard is happy to help with an application and to run a planting event once lockdown restrictions are eased. Could be November 2021.

Skipton Properties intend to complete re-site of seat by 15th January.

11. Consideration was given to Anti-Social behaviour within the village.

The local PCSO had suggested a shelter similar to the one at Whalley. Councillors were not familiar with this. The situation will be reviewed in a couple of months.
